A SUMMARY OF THE APPLICABLE TIME PERIODS FOR WHICH COMPONENTS AND PARTS ARE WARRANTED IS LISTED ON THE REVERSE SIDE SCHEDULE.

The New UD Base Vehicle Limited Warranty covers any repairs or adjustments needed to correct defects in materials or workmanship on all parts of your UD Vehicle, except those listed as not covered in the Warranty & Service Booklet. The New UD Engine, Drivetrain, Chassis Frame and Front Axle Limited Warranty covers all parts listed under this section on the reverse side schedule. The New UD Cab Perforation from Corrosion Limited Warranty covers only perforation due to corrosion and as a result of defective material and workmanship on all cab panel parts of your new UD Vehicle. Corrosion other than perforation may be covered under other warranties. Your New UD Vehicle is also warranted to conform to U.S. EPA emission and noise control standards. Original tires are warranted by the original tire manufacturer, and not by Nissan Diesel America. The Radio and Air Conditioner Limited Warranties cover all parts of radios and sealed refrigerant portions of air conditioners distributed by Nissan Diesel America, except those listed in the Warranty & Service Booklet as not covered. In addition, the UD Vehicle Warranties generally do not cover maintenance services; damage, failure or corrosion resulting from certain unauthorized acts; corrosion of exhaust system components; normal noise and vibration; and modification or improper repair. Damage to your UD Vehicle caused by failure to perform prescribed maintenance (see UD Owner's Manual) is not covered by warranty. Complete maintenance records should be maintained on your UD Vehicle. Vehicle component parts not manufactured by Nissan Diesel Motor Company, Ltd., may be covered by separate warranties of the respective component part manufacturer and have warranty coverage different from the UD Vehicle Warranty. Consult your local UD dealer for details.

NDA makes no warranty as to bodies, equipment and accessories not distributed by them. Any needed replacement of parts will be made using new or remanufactured parts. NDA makes no warranty as to any vehicles registered and normally operated outside the United States.

Incidental or consequential damages such as loss of use of the vehicle, lodging bills, vehicle rentals, other travel costs, inconvenience or commercial loss are not covered. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.
